Please read these Terms and Conditions before signing to join the rebate scheme.

1. The scheme is administered through Lucis Pharma Ltd and is available to all Dispensing Practices in the UK on the specified product mentioned on Page 1 of this agreement, procured for dispensing patients only.
2. This discretionary scheme is distinct and additional to any wholesaler discount available on stock ordered through AAH, Alliance or Phoenix.
3. The rebate scheme will be operated monthly, three months in arrears to accommodate NHSBSA Prescribing and Dispensing Data.
4. Lucis Pharma Ltd will contact the practice via e-mail monthly, three months after the month to be claimed for to request procurement data via invoices from the practice supplier[s]. Practice details will be used for this purpose only and will be stored securely and in line with our data protection policy.
4. Lucis Pharma Ltd will automatically rebate practices via procurement data provided by the practice once procurement data has been verified against prescribing data. This will be defined by NHS prescription data.
(Reference for monthly data: England & Wales: NHS Prescription Services, part of the NHS Business Services Authority (NHSBSA), is the provider of the England data and the NHS Wales Shared Partnerships Services is the provider of the Wales data.)
5. Rebates will be paid monthly via BACS payment only when all practice procurement data has been received.
6. A participating practice must submit their quarterly usage upon request within 90 days otherwise forfeit the accrued rebate for that specified month.
8. This Lucis Pharma Ltd Rebate Scheme commences 1st December 2021 and will run for no less than 12 months. After 1st December 2022, Lucis Pharma Ltd may make amendments to the scheme with no less than one month's written notice to all those signed up to the rebate scheme.
