The Drug Tariff

The Drug Tariff

- Determines the reimbursement price of most medicines available on an NHS Prescription
- Determines other payments to ***pharmacy***
- Determines standards and quantities
- Is the cost control mechanism for Primary Care prescriptions
- Written primarily for pharmacy ***not all sections*** relate to Dispensing Doctors

What is Category H? Drug Tariff Definition [not helpful really]

2.3 Category H - Drugs which are not readily available as licensed generic medicines and are available from more than one supplier. Category H reimbursement prices are set using information from suppliers obtained under the Health Service Products (Provision and Disclosure of Information) Regulations 2018. All available pack sizes will be considered. Broken Bulk may be claimed, if necessary.

What is Category H? Simply Explained

- Over time manufacturers have created versions of established branded medicines
- i.e. Pseudoephedrine hydrochloride 60mg tablets
- And the Drug Tariff Price until now has been based on the [usually] original brand Sudafed
- However, the original brand price doesn't necessarily reflect the actual purchase price OR NHS List price of the various alternatives



Why have they introduced Category H?

- Presumably to save the NHS money by lowering the reimbursement price of items to a figure closer to the actual purchase price
- Prescribing only GPs will write generically by default for most medicines UNLESS there is a clinical/social argument
- Should m/r x/l prolonged release medicines be written generically?
[doxazosin 4mg m/r is now Cat H and is prescribed generically 95% of the time]
- The new National Formulary [?]

Category H Key Points

- March 2026 a slow start [testing the waters?]
- June 2026 very little change
- Prices calculated quarterly
- A “phased approach” to gradually move items from Cat C [Original brand price] to Cat H [price calculated and based on “market data”]

Example Etodolac 600mg

- Homework
- Consider the acquisition cost first!
- Etopan XL dm+d = ?
- Lodine SR dm+d = ?
- Is Lodine SR discounted?
- Is Etopan XL discounted?
- What about Parallel Imports?
- Are there any generics available?



Category H What Do You Need To Do?

- Have a system in place!
- The most basic thing to consider is; has the reimbursement price gone down? If so then some further action may be required.
- If the reimbursement price has gone up, then less likely to have an impact BUT suppliers may react to a Drug Tariff rise by upping their prices...



Category H What Do You Need To Do?



- YOU have control over the prescription [unlike community pharmacy]
- It is still all about the ***purchase price*** vs the ***reimbursement price*** – **check one vs the other**
- **Decide which items to prescribe by brand and which to leave as generic**
- Reimbursement price for a generic prescription [Cat H] Drug Tariff vs reimbursement price for a branded prescription [dm+d]
- Remember dm+d overrules Drug Tariff via endorsing and prescribing in the main body of the prescription

Category H Further Suggestions

- Look at your systems and processes for ordering/checking [have a laminated CAT H list in the dispensary for reference?
- Where you have decided to prescribe by brand add a sticky note to the generic location on the shelf?
- Give your prescribers a list of items to prescribe by brand?
- Send generic Cat H prescriptions back to the prescriber where relevant?
- Alter the Cat H prescription where relevant or endorse in the main body?

- Familiarize yourself with and use the Dictionary of Medicines and Devices
- A whole session in itself – not planned but bespoke training is always available

- Prices mostly going up [?]
- BEWARE the future and keep checking the Drug Tariff preface regularly!
- There may be some shocks in the future
- **Oxycodone?**
- **Inhalers!**

The Drug Tariff: Part VIII A Medicines

- Category A reimbursement based on a basket of prices – price can change monthly
- Category M reimbursement based on agreed profit left in the supply chain for Community Pharmacy – price usually changes quarterly [occasional monthly change in exceptional circumstances]
- Category C reimbursement based upon a particular brand, wholesaler or distributor price – price changes are rare
- Category H reimbursement based on “market data” – price changes and additions quarterly



The Drug Tariff: Part IX Medical Devices

- Generally speaking only medical devices which are listed in Part IX of the Drug Tariff can be prescribed, dispensed and reimbursed
- The greatest source of returned prescriptions and possibly the most confusing for a dispenser!



The Drug Tariff: Part IX Medical Devices

- Changes are coming
- I had hoped to be able to give further clarification by now but changes seem to be delayed [probably due to the complexity of the proposed changes and benchmarks!]



Drug Tariff Part IX [Medical Devices]

- Apologies for bringing along more potential headaches in this area!
- There will be changes to Part IX in 2026 due to consultation
- New “clusters” comparing prices and products
- Could lead to even more confusion and returned prescriptions...
- But could lead to more transparency?



Drug Tariff Part IXA [Medical Devices]

What is the Solution?



- Work out what works in your dispensary – your systems and processes
- Part IXA devices should be prescribed by brand if possible
- Generic prescriptions for Part IXA devices more likely to be sent back or queried
- Is the item being dispensed have a CE Mark [much more likely to be a Medical Device if it does]?
- Sticky labels on shelves to indicate Medical Devices?
- Eye drops [Part IXA Devices] kept in a drawer separate from medicines?
